### Competent Person Training

This new **online interactive micro learning course** has been developed by Accessible Water and Wastewater Solutions Limited. This course **requires a high-speed internet** and is formatted to work on a computer, tablet or mobile device (*Smartphone*) to use anywhere at any time.

This course covers many areas required by Canadian occupational health and safety regulations as well as International OSHA.

It is broken down into modules that range from 40 to 90 minutes each and are designed to allow the operator to do as many or as few in a setting as they may have time for. Modules also allow participants to take the course over time without severely impacting their work schedule.

Even the modules can be stopped and restarted, picking up and continuing where ever they were left off whenever needed.

Online courses save time away from the worksite and is a significant saving in travel time, meals, accommodations, and other expenses associated with traveling when taking a course in person to acquire the required knowledge and continuing education units (CEUs) required for license renewals.

Under the occupational health and safety act the employer is required to provide safety training. This course has been approved by Nova Scotia environment for .8 CEUs and is applicable to operator license renewal for Wastewater Collection and Water Distribution.

These modules are interactive, requiring some input from the operator to keep them engaged, as well as using videos which assist with visual learning.

Upon successful completion, a certificate with approved CEUs will be issued by AWWS which the operator can use for license renewal.

**Each registered participant** will require their own **unique email address to login** as their username. A password will be supplied to login when application is approved.
